




SIGNIFICANT VARIANCE EXPLANATION

A significant variance between two years accounts is defined as one which is over 15%.

Expenditure in 2014/5 was £2,259 (21.1%) less than in 2013/4. The main reasons this were:-

1. In 2013/4 a grant of £3,150 was paid to Hathersage Parish Council towards the cost of operating Hathersage Swimming Pool. With the impending amalgamation of Outseats and Hathersage Parish Councils and the resultant pooling of their funds no grant was made in 2014/5.
2. The cost of maintaining the Playing Field and of street cleaning (for both of which Outseats met 33% of the cost) rose by £775.
